WNSW PHN have a taking a 2 prong-approach to workforce development and capacity-building across our region:

1. to improve the integration between, the AOD sector workforce and the broader primary health care system, including general practices, and to enhance the knowledge of GPs and other health professionals on the application of alcohol and other drugs addiction referral pathways. And increase the awareness of the range of evidence-based resources available to treat drug and

alcohol addiction treatment.

2. build the regional AoD workforce by providing individuals in our communities with opportunities to complete studies that will allow them to pursue careers in community services, focusing on Alcohol and Other Drug support and prevention. The support

industry in relation to alcohol and other drugs services across the WNSW PHN region is in need of skilled, local professionals to provide ongoing support, intervention and management to those communities.

Data will show there is a lack of skilled workforce in our region, particularly in our rural and remote regions, workforce needs are increasing in the NGO sector and there is a growing need to staff and support the establishment of new service opportunities that are coming to our region.

Description of Activity *

- 1. NSW PHN will continue to commission the Alcohol and Other Drug (AoD) Practice Specialist program which will support primary health professionals and specialists in WNSW PHN funded AoD programs through a range of clinical supervision, practice support and education and training activities. These positions will also support and engage primary health care partners to develop and improve service coordination and develop the workforce to respond to drug and alcohol conditions.
- 2. The program provides students with ongoing guidance and support on the basis of a full scholarship, to complete the certificate IV in community services, with a focus on alcohol and other drugs prevention, education and management. The program component is made up of 7 core units, 8 electives. The 4 AoD elective units' cover:
- Work in AoD context,
- Assess needs of clients with AoD issues,
- Recognise and respond to crisis situations and
- Develop strategies for AoD relapse prevention and management.

The program goals include:

- Education and training to everyday individuals who wish to gain or continue their work in their local community.
- Assisting in building the skills gap identified within the WNSWPHN, especially in rural and remote communities.
- Assisting as many students as possible to complete their qualifications and gain employment in the community services industry.
- Assisting students to unleash their community service potential and make a difference in helping their community to thrive. 'At workforce support, we believe that supported communities -support community'.

Aim of Activity *

The prevalence of alcohol dependence is higher in Western NSW, than the State and National average. To support individuals with Alcohol and other drug dependence, WNSWPHN commissioned the Clean Slate Clinic a home detox delivery service, to improve the health and wellness of individuals, struggling with alcohol, cannabis and methamphetamine dependence. This service ensures withdrawal (detox) and recovery services are accessible to residents across the whole WNSW PHN region.

Description of Activity *

Continue to commission Clean Slate and work towards increasing the number of places available for individuals' experiencing substance use problems across the region, including communities that have a high number of Aboriginal and Torres Strat Islander people.

Services activities include, preparing clients for a clinically led telehealth home detox, assessment and treatment, support and follow-up, clinical supervision and case reviews, and educational and training sessions. Health promotion & information sessions are also held at community events and in small groups settings if requested.

The education & training component that is delivered to GPs, AOD providers and health care practitioners, aims to improve the capacity and capability between, the AOD sector workforce and the broader primary health care system. Including GPs, AOD providers and other health care practitioners will ensure extra support is provided for people with substance abuse issues to

access appropriate treatment options and referral pathways.

The aim of this program is to improve health outcomes and reduce harms associated with substance use among Aboriginal and Torres Strait Islander community, through commissioning of AoD services that increase access to assessment and treatment for consumers experiencing AoD problems in regional and remote Western NSW.

Services will include the provision of a 6-week mobile drug and alcohol rehabilitation program which targets rural towns, where access to intensive support and counselling is currently not available. The program includes structured therapeutic groups, support and education/information sessions. Interventions will vary based on client need but will include evidence-based therapeutic intervention including contingency management, community reinforcement approach, relapse prevention, motivational enhancement therapy and social skills training. There will be a strong aftercare component to support the client following initial treatment.

The Provision of a AoD Mainstream and Indigenous evidence-based alcohol and other drug treatment services for clients using a range of substances, as well as flexible and stepped care models tailored to the individual's need and stage of change. Providing integrated approaches to drug and alcohol treatment services based on the needs of clients locally, focusing on improving care coordination at the local level

Description of Activity *

• The supplier will deliver the program at least five times during the contract period in Parkes (Indigenous Specific Program)

- The supplier will ensure that a minimum of 50% of program participants (48 clients) are Aboriginal or Torres Strait Islander people.
- The supplier will ensure that 100% of program participants in the Parkes LGA identify as Aboriginal or Torres Strait Islander people
- The supplier will deliver clinical consultations and roll out community engagement activities including education, early intervention and other support to clients in communities.

The provider will improve the health and wellness of individuals struggling with alcohol dependence and make withdrawal (detox) and recovery services accessible to every Australian who needs them, irrespective of postcode or socio-economic status. Supported by GP, registered nurses.

The provision of a mobile drug and alcohol rehabilitation program which targets Parkes, where access to intensive support and counselling is not available. The program includes structured therapeutic groups, support and education/information sessions. Interventions will vary based on client need but will include evidence-based therapeutic interventions.

Furthermore provision of evidence-based alcohol and other drug treatment services for clients using a range of substances, as well as flexible and stepped care models tailored to the individual's need and stage of change. Providing integrated approaches to drug and alcohol treatment services based on the needs of clients locally, focusing on improving care coordination at the local level.

Access to timely residential rehabilitation services across WNSW PHN has been an ongoing challenge. WNSW PHN will implement

an AoD Navigator Program Pilot that will support eligible Aboriginal and/or Torress Strait Islander people in navigating access to treatment and supports in community, whilst they await entry into appropriate AoD residential rehabilitation programs. The Program will be led by The Glen Centre and will also work to build the capacity of all other First Nations led AoD providers across the WNSW PHN footprint. Independent evaluation of the pilot will inform a review of the learnings, with plans to publish findings.

As part of our future work, Western PHN will review and evaluate all current AoD services to identify key priority populations, such as Aboriginal & Torres Strait Islander people requiring increased access to AOD services and work in partnership with out LHDs and primary care providers to ensure improved access to all communities.

We will continue to commission youth specific services to be delivered in accordance with best practice and evidence-based including appropriate treatment interventions. This includes services for young people with both low risk and complex needs to ensure they can access, safe high-quality services suitable to their needs. We will continue to work in partnership our LHDs and AoD providers who specialise in Youth specific services in 2025 and 2026, to re-design our commissioned services with an overarching alliance approach to best practice and evidence-based interventions methods.

We will continue to support communities with evidence-based treatment options such as incorporating AoD support into headspace, provide access to detox facilities and provide follow-up support services and re-design services for Aboriginal people in partnership with ACCHOs and community.

Using the Alcohol and Other Drug Treatment Services National Minimum Data Set (AODTS-NMDS) as a basis, Western PHN will standardise the collection of data from commissioned AoD treatment service providers to inform the continuous quality improvement of AoD treatment services in the region. Service Provides are required to provide Western PHN with quarterly reports including outcome measures.

Aim of Activity *

To deliver interventions to young people with AOD issues within our headspace centers, with a focus on Broken Hill & Bathurst. The program will ensure that young people experiencing AOD issues are able to access appropriate treatment in a youth friendly setting. There will also be an opportunity to educate headspace staff and GPs who refer into headspace centers.

Description of Activity *

Facilitate and support evidence-based treatment for young people who use alcohol and other drugs and build- capacity of headspace staff to work and support these young people. General Practitioners have been identified as the second highest referrer into our headspace centers, we will work closely with our primary care providers through our education program to ensure they are aware of any new treatment services.

WNSW PHN will commission AOD specialists, to provide treatment services into the Broken Hill and Bathurst headspace centers, with a view to extend to our Dubbo and Orange Centers. It is our intention that the commissioned provider will be an AOD clinician who will deliver AOD counselling services to young people who have been identified as benefiting from a higher intensity specialised intervention. The AOD clinicians will also be able to provide support to other headspace clinicians.

Our headspace centers report highlights primary issues for a young person's first visit notably as Mental Health and behaviour, this is selected based on the issue that the provider spent the most time on. It is important to note that the report points out that

secondary issues such as alcohol and/or drug specific interventions may be under-represented due to this. Alcohol and other drugs are listed as 3rd on the primary issues of presentation, highs
