WNSW PHN will commission Head to Health Services across the Western NSW PHN region. These services aim to increase availability and access to appropriate mental health assessment, support and co-ordination of services within the region, while reducing stigma and reducing the amount of unnecessary mental health admissions.

This activity aims to improve targeting of evidence based psychological interventions to most appropriately support people with, or at risk of, mild mental illness. The service provides a holistic approach to mental health, psychical health and the co-ordination of services for people who are seeking mental health support.

Description of Activity *

WNSW PHN will commission the co-design and establishment of locally tailored Head to Health Centre across the region, commencing with Dubbo and Bathurst

Each Head to Health service provides innovative models of care and will be tailored to the needs of our local community and offers a combination of peer-led recovery and clinical support to provide a warm, welcoming and high-quality experience including:

- Head to Health services aimed to ease the burden on the public hospital system and provide more accessible services to those needing mental health support, their carers and families.
- respond to people experiencing crisis or in significant distress.
- provide a central point to connect people to other services in the region, including offering information and advice about mental health, service navigation and referral pathways for individuals and their carers and family.
- provide in-house assessment using the IAR decisional support tool to connect people with the most appropriate services.
- provide evidence-based and evidence-informed immediate and short to medium term episodes of care, including utilisation of digital mental health platforms.
- Services will be delivered in a culturally safe way to increase accessibility for Aboriginal and Torres Strait Islander People.
- Services will be based on clinical judgement and individual need, including interventions to support those with associated AOD misuse.

This service will Integrate with the national Head to Health intake and assessment phone service.

The WNSW PHN will base their activity on the principles of the Universal Aftercare Model through implementation and integration of new suicide interventions (Prevention, Post-vention and Aftercare services) across both the Far West LHD and WNSW LHD.

WNSW PHN region will utilise place-based care and embed recommendations as provided by the Clinical Agency of Innovation regarding best practice in Universal Aftercare.

Description of Activity *

The Western NSW PHN will commission a local service to deliver The Way Back NSW (TWB NSW), formerly known as The Way Back Support Service. The program aims to reduce the risk of further suicidal behaviour for individuals who have experienced a suicidal crisis or who have attempted suicide.

The key purpose of The Way Back is for the person to reestablish a meaningful life through redeveloping important relationships and purposeful connections they may have lost with their community. Rediscovering a sense of purpose, reestablishing interests and passions in life, and reducing feelings of being a burden are critical for aftercare's effectiveness.

WNSW PHN will continue to commission, the existing aftercare service in Broken Hill, and will transition this services, plus additional services under the new Universal Aftercare Framework.
