## 1. About the Western NSW Primary Health Network

The **Western NSW Primary Health Network (WNSW PHN)**, is one of 31 Primary Health Networks across Australia, established to support frontline health services and increase the efficiency and effectiveness of primary health care. Our focus is people who are at risk of poor health outcomes and working to improve the coordination of their care, so they receive the right care in the right place at the right time. We work closely with key stakeholders including general practice, other health care providers, Local Health Districts, hospitals and the broader community to align services with the health needs of the region.

WNSW PHN is a not-for-profit organisation primarily funded by the Australian Government.

WNSW PHN covers both Far West and Western NSW Local Health Districts across a total area of 433,379 square kilometres, making it the largest PHN in NSW (at 53.5%). The total population is estimated to be over 312,000 people, with 20.3% over the age of 65 years. Approximately 11.36% of people in the WNSW PHN region identify as First Nations (ABS, 2021).

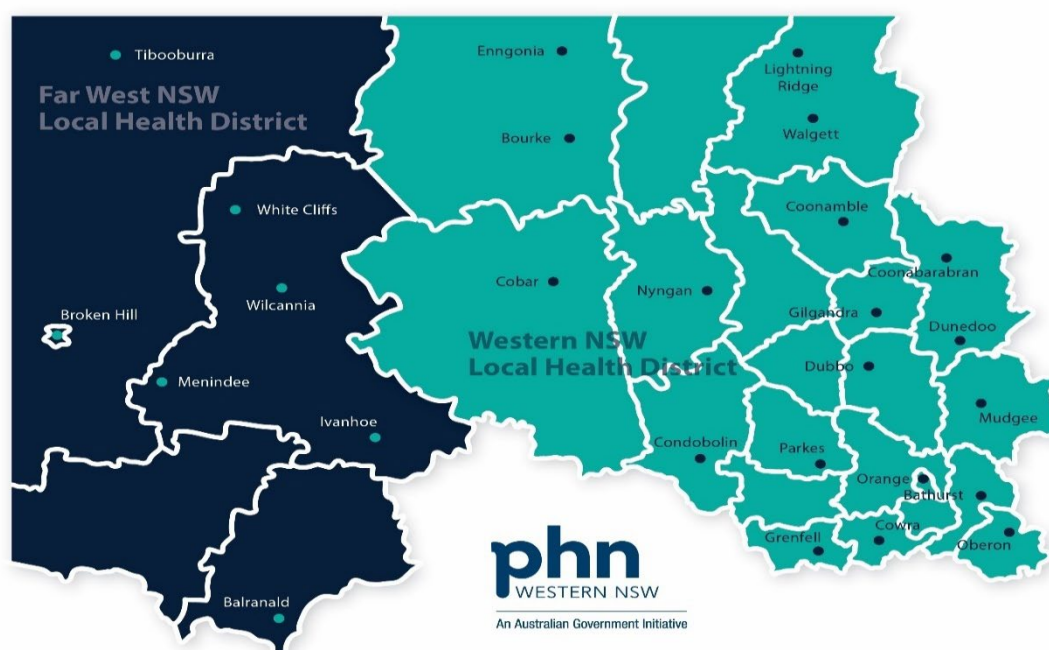


Figure 1 – WNSW PHN Geographical Footprint

## 2. Background – General Practice After Hours Grants Program

WNSW PHN plays a key role in supporting local primary health care services to better meet the health needs of the community. An important element to this support includes enabling equitable access to primary care services in the after-hours period.

For the purposes of this grant opportunity, after- hours primary health care is defined as *‘accessible and effective primary health care for people whose health condition cannot wait for treatment until regular primary health care services are next available.’* It should not be a substitute for primary health care that could otherwise occur during regular business hours, usually given as between 8.00am-6.00pm on weekdays and 8.00am-12.00pm on Saturdays.

WNSW PHN is offering funding through the General Practice After Hours Grant Program 2025 to further enable local General Practices, Aboriginal Medical Services, enhance access to primary health care in the after-hours setting.

1. Support the development of regional responses to address the after-hours primary health care needs of local communities, whilst supporting the after-hours primary health care workforce.
2. Promote coordination between services at a local level and support after hours service providers to integrate care with a patient’s usual primary care provider.
3. Address gaps in availability of after-hours primary health care services.
4. Reduce non-urgent attendances at hospital emergency departments in the after-hours period.

WNSW PHN invites applications from eligible organisations for the Grant Program. Relevant information for application is provided below.

## 3. Key Grants Details

Grant funding is offered to enhance existing after-hours services and/or extend after hours services into the after-hours period. Funding could also be used to enable services to trial new after-hours service models that increase community access to appropriate after-hours primary care services.

Applicants may apply for up to \$80,000 in funding for activities to support existing after-hours services, extend services into the after-hours period or propose a new model of After-Hours Service.

Potential activities that would be considered appropriate include, but are not limited to the following:

- Extension of existing service into the after-hours period (i.e. currently open 8.00am to 12.00pm on evenings or weekends looking to extend hours or shared roster models.)
- Equipment to enable the expansion of services into the after-hours period
- Digital health infrastructure and supports to be utilised in the after-hours period.
- Targeted training and CPD sessions for staff in after-hours service delivery
- Health literacy and community engagement to increase awareness of after-hours services and appropriate use.
- Improvements to access such as transport coordination/facilitation to access an after-hours clinic
- Outreach clinics/service in after-hours period to priority populations
- Nurse led clinics in the after-hours period with GP accessible when required
- Projects that increase capacity for delivery of primary care to Residential Aged Care residents

General practices and Aboriginal Medical Services may apply individually or as a collaboration within a town or across several towns.

Applicants will need to include:

- Description of current after hours services delivered.
- Proposed extended opening hours/new service or service model.
- Demonstrate how the service/ model will increase capacity, access to primary care in afterhours period.
- Staffing required (GPs, nurses, administration).
- Indicative budget; and
- Simple sustainability plan to demonstrate capability of continuing the service beyond the funding period (this should include MBS income and business support systems).

***IMPORTANT NOTE: Proposed services must be delivered in the after-hours period.***

***Applicants are encouraged to review carefully the guidelines and ensure consideration of options that best support local after-hours access and community needs. The funding aims to be flexible and supportive of innovative approaches, recognising workforce availability and community needs vary across the region.***

***WNSW PHN welcomes early discussions prior to submission to clarify expectations, explore models and ensure alignment to the objectives of the grant.***

## 4. Grant Funding Details

**Funding of up to \$80,000 (excluding GST) per eligible organisation.**

### **Funds can be used for**

- Direct costs of delivering the proposed activity (i.e. staff wages).
- Purchase of resources to support the proposed activity.

### **Funds cannot be used for**

- Delivering service activities outside the after-hours period i.e. activities in normal business hours (8.00am-6.00pm on weekdays and 8.00am-12.00pm on Saturdays) that would reduce the after-hours burden).
- Operational costs that do not relate specifically to this activity
- Similar or existing services that are already funded within the community
- The purchase of large value assets such as vehicles or buildings.
- Purchase of assets over \$10,000
- Recruitment costs
- Administrative costs such as auditing costs above 10% of funding provided.
- The preparation of grant application.
- Retrospective items and activities

Funds need to be expended by 30 June 2026.

## 6. Eligibility Criteria

To be eligible for funding, applicants must meet the following criteria:

1. Must be a General Practice, Aboriginal Medical Services operating within communities with a population of 20000 or less the WNSW PHN region.
2. All General Practice applicants must be registered for, and consent to share information via the Lumos Program (or prepared to participate) - more information [HERE](#)
3. Applicants must be registered with, and publish information via Provider Connect Australia – more information\* [HERE](#)
4. Must meet all four digital health\* foundations, which include:
  - 4.1. Actively using My Health Record
  - 4.2. General Practitioners are capable of electronically prescribing.
  - 4.3. Actively using secure messaging
  - 4.4. Have access to a video call platform for telehealth consultations that meets security and safety standards.
5. Must hold relevant insurances, including.
  - 5.1. Public Liability Insurance (minimum coverage \$10 million).
  - 5.2. Professional Indemnity Insurance.

6. Must not have a current grant agreement with the WNSW PHN for after -hours

## 7. Deliverables

- Delivery of after-hours services as proposed and agreed in Grant Agreement.
- Evidence of appropriate insurance coverage.
- Regular service reports/evaluation, which may include:
  - Occasions of service in after-hours period
  - Client demographics
  - Client and Clinician satisfaction
- Unaudited financial expenditure report.
- Final report including evaluation and sustainability plan

## 8. Grant Conditions

1. WNSW PHN will only consider one application per eligible organisation.
2. WNSW PHN reserves the right to award all, part, or none of the Grant.
3. Successful applicants will be required to enter into a Grant Agreement with WNSW PHN.
4. Applicants must disclose potential or perceived conflicts of interest.
5. Breaches of terms may result in Grant recovery.
6. Successful Grants may be publicly listed on the WNSW PHN website.
7. Applicant must ensure compliance with working with children checks.
8. Applicant must acknowledge WNSW PHN in promotions.
9. Applicant must submit reports as per agreement schedule.

## 09. Assessment Criteria

Applications will be evaluated based on:

- Submission of fully completed application.
- Meeting the eligibility criteria outlined in Section 6.
- Evaluation Criteria below:
